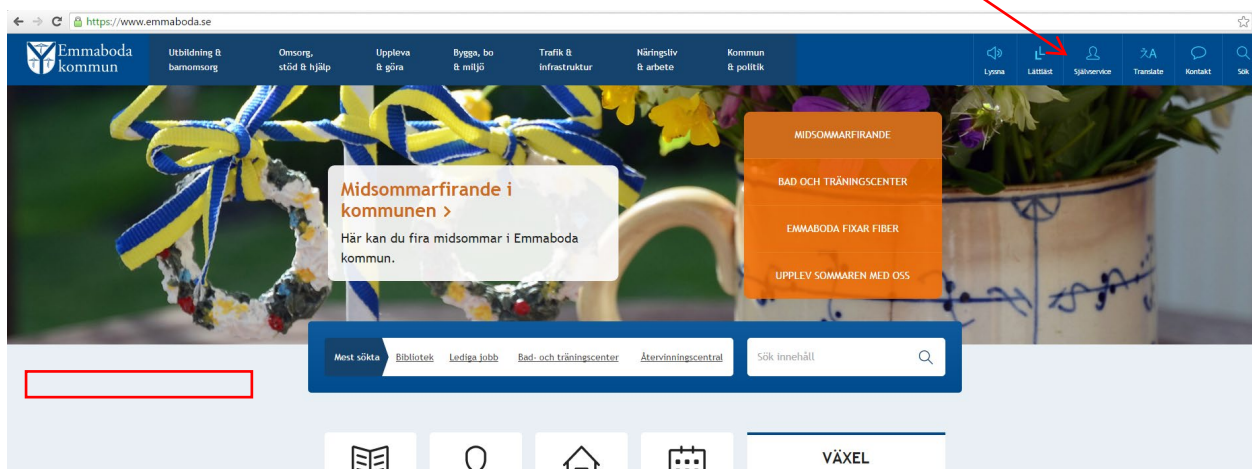

ELECTRONIC ID CHILDCARE

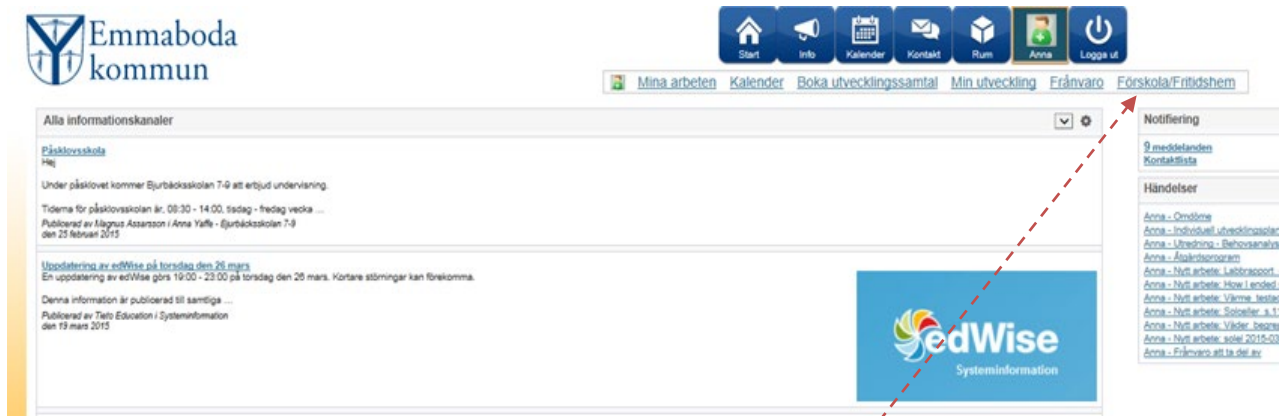
Once you've received a placement in childcare, sign in with the electronic identification (Note! "Cookies" must be allowed) on www.emmaboda.se

SECURE LOGIN REQUIRED

The Swedish Data Inspection Board is the supervisory authority responsible for monitoring how municipalities store information. It is primarily the Data Protection Act and the Personal Act (PUL) that govern the regulatory framework concerning this.

The Data Inspection Board has given Swedish municipalities policies covering the category of e-services, edWise included.

The guidelines indicate that these services must have secure logins to comply with current legislation.
